SWEEPSTAKES DESCRIPTION:

This Sweepstakes will be conducted exclusively online. Listeners of WOSL-FM and WIZF-FM (singularly "Station", collectively "Stations") who are legal residents of the United States residing within the Cincinnati, OH metropolitan area and are 18 years of age or older will be able to take part in this Sweepstakes. - 1. Sweepstakes participants must register online through one of the Stations' websites at www.wiznation.com.
- 2. Upon entering the website, participants are to follow the on-screen instructions, including entering their name, date of birth, address, phone number, email address, and any optional or additional contact information, as requested, to register for a chance to win.
