THE OMS MEMORIAL DAY BBQ GRILL GIVEAWAY OFFICIAL CONTEST RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE A PARTICIPANT'S CHANCES OF WINNING.

PROMOTION DESCRIPTION:

WIZF-FM's "OMS Memorial Day BBQ Grill Giveaway" contest ("Contest") will begin on Wednesday, May 3, 2023, and end on Monday, May 29, 2023 ("Contest Period"). Registration for this Contest will be held online and in person at the Ohio Media School, located at 4411 Montgomery Rd Ste 200, Norwood, OH 45212. One (1) winner will be awarded one (1) Outdoor Gas Grill and accompanying Grill Utensil Kit valued at Three Hundred Twenty Dollars (ARV \$320) and one (1) Visa Cash Gift Card in the amount of One Hundred Dollars (ARV \$100) (Total ARV \$420) ("Prize").

HOW TO ENTER / EXECUTION:

Listeners of WIZF-FM ("Station") who are legal residents of the United States residing within the Cincinnati, Ohio metropolitan area and are 18 years of age or older will be able to take part in this Contest. To participate in the Contest, listeners must do the following:

1. In-Person Registration

- a. Throughout the Contest Period, eligible participants may register in-person Mondays through Fridays between the hours of 9:00 AM and 3:00 PM by appearing at the campus of the Ohio Media School ("OMS"), located at 4411 Montgomery Rd. Ste 200, Norwood, OH 45212 ("Campus"). OMS Staff shall provide participants with a paper Entry Form. Participants must complete the Entry Form, providing their name, date of birth, address, phone number, email address, and any optional or additional contact information as requested.
- b. After completing the registration and while still on the Campus premises, participants will be given the opportunity to record a reading of advertising copy to be provided by OMS ("Read").

2. Online Registration

- a. Eligible participants may also register online through the Station's website at wiznation.com. Upon entering the Station's website, participants are to follow the on-screen instructions on the online entry form, including entering their name, date of birth, address, phone number, email address, and any optional or additional contact information, as requested.
- b. After completing the online registration, participants must visit the Campus during the Contest period on Mondays through Fridays between the hours of 9:00 AM and 3:00 PM to perform their Read.
- 3. To be eligible to win, participants who have properly completed the registration process and recorded their Read must also physically attend The OMS Memorial Day BBQ Grill Giveaway with Tropikana powered by Radio One Cincinnati ("Event") to be held at the Campus on Wednesday, May 31, 2023 between the hours of 3:00 PM and 5:00 PM.

- 4. Upon the conclusion of the Contest period, a panel consisting of OMS and Station personnel will select the best Read, to be determined by the following criteria:
 - Appropriateness of pitch, tone of voice, and diction for the copy.
 - Clarity and enunciation.
 - Timing and pacing.
- 5. The participant with the best Read ("Potential Winner") must attend the Event to be announced as the Winner. (see below for details).
- 6. During the Event, at approximately 4:45 PM, the Potential Winner will be announced. Potential Winner must be present at the Event at the time of the announcement or their prize will be forfeited and an alternate Potential Winner selected. The first Potential Winner who is present at the Event when announced ("Winner") will win the Contest and be awarded the Prize (see "Prize" below for details).
- 7. One entry per person during the Contest Period, regardless of registration method.
- 8. In the event of a dispute regarding the identity of a participant's online entry, the entry will be deemed to have been made by the authorized holder of the e-mail account at the time the entry was made.
- 9. Winners must provide valid identification (e.g., via valid state-issued driver's license, passport or other government-issued I.D. containing the person's name, date of birth, and photograph) and a completed W9 form to claim the prize. Identification documents must match information previously provided to the Station.
